#### 1. (a) Draw an inference from the text.

**3.** Identify a theme of "Hanging Fire" that concerns the idea of waiting. Explain how the details in the poem support this theme. Remember that the term *hang fire* means "to do nothing" or "to wait." In your explanation, discuss how *hang fire* and other references to waiting help develop the theme.
